Material relating to Still's military career, especially his efforts to obtain a pension starting in 1877. (His difficulties arose largely from having served in militia units rather than the regular Union army; the fact that some documents were filed under "Andrew P. Still" probably didn't help. He was finally awarded a pension of \$12 a month in 1904.) Nearly all are copies, many of Bureau of Pensions documents at the National Archives. Also includes statements by Charles Still about his father's military service.
