Unidentified group of children and teacher outside a school; [early 1900s]. B&W; original size (before break) 25.2 x 19.3 cm; mounted (overall size ca. 28.7 x 24.8 cm).
Group of 59 children and 1 teacher outside a school; early 1900s. B&W; 19.4 x 11.5 cm; matted (overall size 23 x 17.9 cm). Photo is labeled "My first grade picture" in what may be CES Jr.'s handwriting; however, no child in group resembles CES at that age and the clothing suggests photo is earlier than 1913 (when he would have been in 1 st grade). First boy at left in front row strongly resembles Andrew T. Still II, who would have been in first grade in about 1904, leading to the conclusion that this is actually Andrew's class picture, not CES Jr.'s.
Unidentified group of children and 1 adult, most wearing costumes, outside old [Charles] Still home; [ca. 1907?]. B&W; 24.6 x 19.5 cm; matted (overall size 28.6 x 23.5 cm). Group includes Gladys Still (tall girl in white dress) and possibly Elizabeth Still (back row, holding hand up to mouth); partial identification (destroyed by cutting of mat) suggests that Fred Mix Still and Richard Still are also among the children. Photographer: Samuels, Kirksville, MO.

Box 6: Medical Bag Contents

According to the family, these items all came from the medical bag of A.T. Still.³ The June 1917 patent date on two items—six months before ATS's death—casts doubt on whether the medical instrument were actually owned by ATS. A more likely explanation is that some items were placed in the bag later.

Bones: 10 vertebrae (7 articulated on [twine], 3 loose)
Eye bath: dark blue glass, 2 5/8" high, bowl 1 1/4" deep.
Nasal speculum: 5", blades 1 1/4."
Ear speculum: 1 3/8" long, 5/8" dia. at wide end.
Hemostatic forceps: 5 5/8" long, marked "Lawton Stainless Germany", with small patch of dark green tape wrapped around one handle.
Headband: black web frayed and slightly torn at edges of clamp, silver clamp with dark amber lump on it, silver adjuster slightly rust spotted.
Black leather case, 4 1/4" x 2" x 3/4", scuffed, inside lid printed in silver: "DE LYTE SURGEON" PATENT 6-12-'17 WEDER MFG. CO., PHILADELPHIA, PA.; contents: round magnifying glass on handle, 2 7/8" long, 1" dia.; eye scoop, 4 1/2" long, metal, with several rust spots, marked "TRUAX, GREENE & CO" on handle; ophthalmoscope light, 2 7/8" x 1 3/8" x 7/8", silver, with rust spots, marked: WEDER-PHILA. PAT. 6-12-17[?].
Instrument used to secure tongue depressor for oral examination: 3 1/2" long, clamp 1 1/4", metal with 3 oval holes at end (each 5/8" long), with some rust spotting, marked "PAT. 6-12-17," possibly originally part of kit above.
