PROGRAM AND CURRICULUM

- » Audiology is the science of auditory vestibular processes.
- » The audiologist is concerned with the anatomy, physiology, and pathology of the auditory and vestibular systems, as well as treatment of hearing and/or balance disorders.
- » The curriculum includes in-depth didactic and scientific foundation classes and hands-on labs.
- » The four-year/162.5-semester-credit-hour doctoral program has clinical rotations beginning in year one and culminating in full-time rotations in year four.
