CURRICULUM

DIDACTIC YEAR (14 MONTHS)

- » Large-group lectures (case studies, interactive clickers, and projects).
- » Small-group labs working with other students and faculty to practice skills (clinical skills, procedures, history taking, and physical exam).
- » Curriculum delivered in mixed format.
- » Standardized patient encounters.
- » Didactic clinical experiences in Arizona include supervised clinical experiences at emergency dental clinics; ear, nose, and throat clinics; care of the homeless and individuals rehabilitating from substance misuse; and falls prevention training.
- » Work closely with preceptors and patients.
- » Early entry availability for the Doctor of Medical Science program.

CLINICAL YEAR (12 MONTHS)

- » Eight six-week supervised clinical practice experiences at sites throughout Arizona or at a CHC partner located in various parts of the U.S.
- » Clinical practice experience areas include family medicine, internal medicine, pediatrics, emergency medicine, women's health, general surgery, behavioral health, and elective.
