Disclosure Regarding Academic Curriculum Requirements for Licensure

Doctor of Audiology

Federal regulations require ATSU to disclose to prospective and enrolled students whether a program leading to professional licensure or certification meets the educational requirements in each state and U.S. territory. Audiology is a licensed profession in all 50 states and U.S. territories. To become licensed to practice as a doctor of audiology, a student must graduate from a program accredited by the Council on Academic Accreditation in Audiology and Speech-Language Pathology of the American Speech-Language-Hearing Association and pass the national certification examination called the Praxis exam administered by the Educational Testing Service. ATSU's Doctor of Audiology degree program is accredited by the Council on Academic Accreditation in Audiology and Speech-Language Pathology of the American Speech-Language-Hearing Association. The curriculum of the residential Doctor of Audiology program is designed to meet educational requirements for initial licensure to practice as a doctor of audiology in every state and most U.S. territories. Please note that the post-professional online programs are not designed to meet the qualifications for initial licensure.

State requirements for licensure are subject to change. These statements and program completion do not guarantee licensure. ATSU cannot provide verification of an individual's ability to meet licensure requirements unrelated to its educational program. Students are encouraged to review licensure requirements (including noneducational requirements such as certification/examination work experience, background checks, etc.) for the states in which they intend to seek licensure.
